AVAILABLE PACKAGES:

BRONZE PACKAGE: \$1000. Up to 5 hours of shooting still digital photographs with minor editing of photos. One 8"x10" Photo and a Signature 12x12 Album containing 20 pages of photos is included. Additional photo prints may be purchased as indicated in Table 1.

SILVER PACKAGE: \$1500. Includes items in Bronze Package, plus 2 extra hours of shooting, and presentation of most all the photos taken in a slideshow format with background music and random transitions on a DVD.

GOLD PACKAGE: \$2000. Includes items in Silver Package plus a 30-32 minute digital video showing high-lights of the wedding and reception presented on a DVD with background music.

BACKGROUND MUSIC: To avoid legal issues, royalty free music will be included on the finished DVD. The following genres of music are available: corporate, cinematic, rock, comedy, funky percussive, jazz, Christmas, hip-hop, dance, pop, country, EZ listening, new age, and wedding. the selections you would want placed in your slide show/movie. Each slide in your show should last 6-8 seconds so determine how many songs you would need (i.e., 100 slides x 7 seconds = 700 seconds or about 12 minutes worth of songs).

An additional \$50 fee will be charged for each 5-30 minute increments above the time allotted in the various packages.

All prices indicated are within a 50 mile radius of Greeley. Mileage fees outside of this area will be assessed based on the current IRS mileage reimbursement rates.

1. Copyright: Except as noted below, all photographs created by Creative Photographic Services are copyright protected. It is a violation of federal copyright law to copy, scan, or allow photographs Creative Photographic Services have created to be reprinted, duplicated, digitally reproduced, copied, scanned, or altered (digitally or otherwise), without the photographer's express written permission. The Client agrees to purchase wedding photography prints directly from the photographer unless in possession of the digital files which can be purchased separately. The digital files remain our sole property unless purchased by the Client.

2. Limits of Liability: While every reasonable effort will be made to produce and deliver outstanding photographs of the wedding events, the entire liability of The Photographer to the Client for any claim or loss arising from our performance is limited to a refund to the Client of the amount paid for services. Because a wedding is an uncontrolled event, the photographer cannot guarantee delivery of any specifically requested image(s). In the unlikely event of personal illness or other circumstances beyond the control of the photographer, the Client will receive a full refund of all money paid. The photographer will not be held liable for the finished product or incomplete coverage in the event of tardiness or time restrictions placed on the photographer by Client or any outside vendors, including clergy or church restrictions and/or policies on the day of the event.

Emergencies such as serious injuries, serious illness, or death to the Client's signing this agreement or their immediate families will cause this agreement to be null and void. Photographer will return any retainers made and will not charge for time or material expenses incurred while preparing for the shoot. Client(s) must produce documentation in writing showing cause stating reason, relationship and have an excuse signed by an attending physician, charge nurse, or funeral director. For the purpose of this agreement, immediate family will consist of parents, stepparents, brothers, sisters, spouses, children, stepchildren, grandchildren, and grandparents of the bride or groom.

3. Payment for Services: A retainer of 30% is due at the signing of this Agreement. Upon receipt of the retainer the photographer will reserve your date and time, and will not make other reservations for that time and date. For this reason all payments are not refundable—even if the wedding is cancelled unless due to an emergency. The retainer is applied toward your total investment agreement. We will not reserve your wedding date until after receipt of the retainer. You may not transfer the retainer to another party, bridal couple, or anyone else without our prior written consent. The final payment of the balance owed is due no less than seven days before the wedding date. Note that photography will not start until this is paid. If this Agreement is signed less than seven days from the wedding date, then all payments are due at signing. If the remaining balance is not paid in full seven days prior to the scheduled date of the event, we reserve the right not to photograph the event.

4. Permissions: It is the Client's responsibility to schedule and receive permission to use various locations for photography, including the wedding and reception locations and any other locations used during the day.

5. Website: A presentation of the proof images is ordinarily made available online on a password protected website within three weeks following the event. Client agrees to allow Photographer to distribute a small notice to guests with the web address of event and event ID information. Online gallery is available for 60 days.

6. Ordering Individual Photographs: Orders for reprints and enlargements can be accomplished online via the password protected website within 60 days after posted. Unless otherwise specified, custom orders will be delivered within 2-4 weeks following payment for order. The online gallery is available for 60 days. Depending on the size of prints ordered, prices will range from \$1-\$30 + tax, shipping, and handling.

7. DVD Slideshow/Video: The images to be used in the slideshow/video will be selected by the Photographer. Royalty free music will be used unless client provides written permission from the recording company to use copyrighted music in the slideshow.

8. Meals: In order for Photographer to make arrangements for her and her associate, they request information about whether meals will be provided or not. (Do NOT feel obligated, Photographer just needs to plan accordingly.) ____ Yes ____ No

10. Travel Expenses will be incurred for event outside of a 50 mile radius of Greeley, CO. Client agrees to pay The Photographer mileage expenses based on the current mileage reimbursement rates outlined by the IRS.

11. No part of any order will be delivered until the balance is paid in full.

12. Model Release: The Photographer may only make reproductions for the Client or for the photographer's website, portfolio, samples, self-promotions, or for professional competition and review. We will not make reproductions for other use without first obtaining written permission from you.

This Agreement incorporates the entire understanding of the Parties, and the Parties agree to all its terms, and acknowledge receipt of a completed copy of the Agreement signed by all Parties. Any modifications of this Agreement must be in writing and signed by all parties. Each person signing as Client(s) below will be fully responsible for ensuring that full payment is made pursuant to the terms of this agreement.
